Consignors will be required to present their consignor number and personal ID to collect any money that is owed.

The Lily Pad will make every effort to sell consigned items but makes no guarantee that any items will sell during the contract period. Pricing, markdowns and periodic sales are at the discretion of The Lily Pad. After 30 days of consignment, any items remaining on the sales floor may be marked down by 25%. Pricing, markdowns and periodic sales are at the discretion of The Lily Pad.

The Lily Pad will make every effort to safeguard your items but is not liable for loss of consigned items thru fire, theft, vandalism, natural disaster or in-store damage.

By signing this contract, Consignor agrees to all of the terms and certifies that all items brought in for consignment are owned by the consignor with the rights to sell said items.
